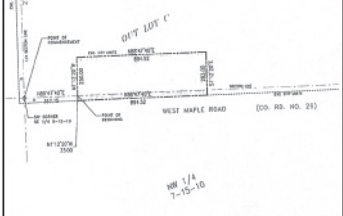
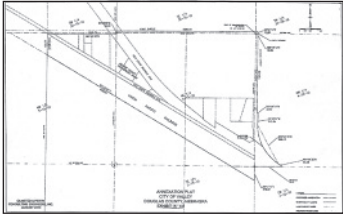
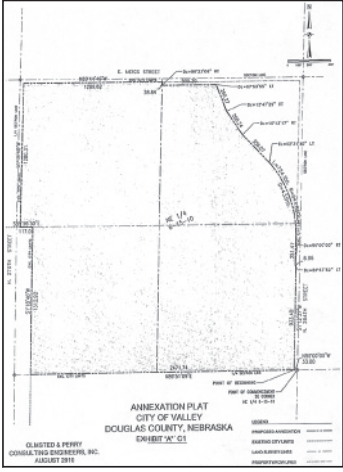

The Nebraska Department of Environmental Quality (NDEQ) proposes to reissue with change the National Pollutant Discharge Elimination System (NPDES) permit to the Douglas County SID #177 Riverside Lakes for the SID #177 Riverside Lakes WWTF, 224 Shorewood Lane, Waterloo, NE (NPDES# NE0112283; SIC 4952). The POTW which receives and treats domestic wastewater is an activated sludge process. Treated wastewater is discharged through Outfall 001 to the Elkhorn River, Segment EL1-10000 of the Elkhorn River Basin. Treated biosolids are hauled to Fremont, NE WWTF for further treatment. The permit will be issued for a period of up to five years and would restrict pollutant discharges to comply with the requirements of Department regulations. The draft permit, fact sheet and other public information are available for review at NDEQ's Lincoln Office (address below) between 8:00 a.m. and 5:00 p.m., weekdays, excluding holidays. EMS students, community members take Purple Hands pledge against bullying

Elkhorn Middle School students learned about dealing with bullies and respecting themselves and others as they celebrated their sixth annual Purple Hands Rally on November 4.

Purple Hands is an anti-bullying and tolerance program in which students, parents, faculty and community members pledge to stop bullying at their school. A group from an organization called RESPECT performed a skit entitled "Spell It Out" to emphasize how peer pressure and harassment can affect the entire student body. RESPECT is a research-based, nonprofit organization based in Omaha that was founded by child psychologist Dr. Patricia Newman.

In their program, the actors interacted with the students throughout the play to educate them in how to identify situations in which they may feel peer pressure and to learn healthy strategies to use if they feel pressure to engage in unhealthy behaviors. After the skit, the actors talked with the students about what they had observed. The actors pointed out that that there is help when kids are bullied, and there are people who care. Some of the most powerful allies, they noted, are other kids at school who will stand up for those who are bullied.

Fighting back is not the answer, they explained, because aggression makes people more aggressive. Getting away from the bully and reporting his or her behavior are options. The actors from RESPECT emphasized that spectators have the responsibility to report bullying as well. Bullying can be verbal, physical or social, such as telling people's secrets, or saying threatening things on Facebook. They explained that cyber bullying can be tracked, and students should print out the evidence so they will be able to show it to parents, teachers or counselors.

EMS Counselor Deb Wesch invited guests from the community to the rally and invited them to join in the pledge that the students also took, which states: "I will not hurt my hands or my words for hurting myself or others."

Each guest drew the shape of their hand on a sheet of paper and signed it to indicate their commitment to that pledge. The students were invited to do the same during that week. The open hand means "stop before doing anything hurtful."

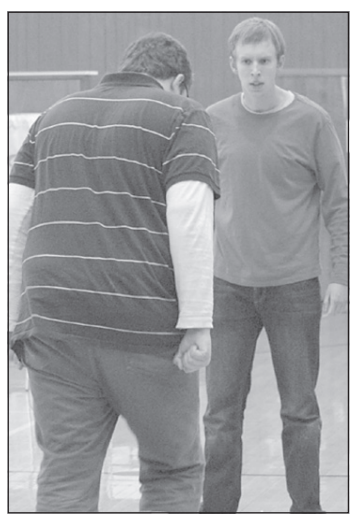
"The red heart in the Purple Hand symbol indicates that when you hurt

yourself or another person, it hurts your heart," Wesch explained.
